The organization served 29 clients during 2015. The clients are defined as disabled, low-income persons over the age of 60 who require in-home care from their caregivers. The program provides a safe place for caregivers to leave their charges in order to take a respite from their 24/7 responsibilities and to see to their own needs. The program also directly helps the homebound individuals by providing access to social interaction and recreation activities, thereby avoiding the dangers of isolation, including depression and illness.
